Safety has long been a mainstay of the A&E philosophy. The company's focus and dedication to providing all workers and subcontractors a safe work environment has been a guiding principle from the start.

A&E'S COMMITMENT TO SAFETY IS EMBEDDED IN ITS CULTURE

Initially, A&E had one full-time employee handling safety. As the company grew, Bob McClure, Senior VP, reached out to Compliance Consultants, Inc. for help since he was aware of their services through his professional connections. In 2009, A&E formally retained the services of CCI to assist the general contractor with all their safety needs.

By implementing regular weekly safety inspections at all active jobsites, creating and implementing the Corporate Health & Safety Program, and providing employee health & safety training, CCI has been crucial in the growth of A&E's safety culture over the years. INCORPORATING SAFETY INTO YOUR PROCESS

Prior to construction, A&E and Compliance Consultants, Inc. meet with project representatives to establish a project-specific safety program which incorporates *A&E's Health and Safety Program*.

This project safety program is then incorporated in the subcontractor procurement process to ensure that the entire construction team understands the necessary safety components for each job. Prior to starting work onsite, the subcontractor safety programs are reviewed to ensure that field personnel are prepared to follow the plan.

Fran Baylis, President, notes that, "CCI provides us with real time, feet-on-the-ground assessment and feedback so we can implement any necessary changes right away and make the field staff aware of the safety requirements for that site."

Project safety inspections are performed weekly and independently by CCI to ensure proper implementation of OSHA requirements and A&E Policy. This weekly reporting assures that all necessary recommendations from CCI are acted upon immediately. Bob adds, "I love the reports. I read the reports. I get real time feedback from them, so I know which Superintendent is doing what."

Field superintendents at each site have daily responsibilities to ensure that the project safety program is being implemented on a regular basis. The entire site construction team is also responsible for reinforcing the project safety program daily. CCI is always available to the project teams to provide support when it's needed.

For example, on the PhilaPort Distribution Warehouse Project, CCI was involved from the very beginning of the site work, through the structural steel installation, roof installation all the way down to painting and finishes. CCI was truly a partner through all phases of construction.

Additionally, CCI has provided highly specialized safety consulting in unique construction situations. For example, on the Summerdale Warehouse Project, A&E chose to install the building's large HV/AC units with the use of a helicopter to save costs on a crane. CCI was able to guide A&E job site management through the safety process for the use of an on-site helicopter pick.

BENEFITS OF AN OUTSOURCED SAFETY CONSULTANT

Over the course of the partnership, A&E has seen the many benefits to partnering with an outside safety consulting firm.

First was the evidence of how important it is to have people on the team who are truly, one hundred percent focused on safety and the unique safety regulations and precautions needed. In-house staff often wear many hats and must prioritize safety along with other competing responsibilities. In 2020 alone, CCI performed over 800 safety inspections for A&E, a number that no one employee could thoroughly cover.

Additionally, having a third-party consultant ensures that all recommendations and advice given are objective. External resources are better positioned to provide neutral assessments, feedback, and implementation plans. CCI is also uniquely equipped to handle unannounced OSHA inspections.

However, the most surprising realization is that it's often a cost savings to hire outsourced expertise, rather than have someone in house where a full-time salary and benefits are costly.

Further, CCI provides regular business reporting such as the OSHA Injury & Illness Recordkeeping Report which helps keep A&E informed and compliant. CCI can quickly review OSHA 300 logs to ensure that the injuries listed are, in fact, recordable. A frequent blunder we often see.

Additionally, CCI customizes safety programs for each client, such as A&E, and they can create a safety plan for each specific site within a client's portfolio. This way,

A&E knows exactly what they are paying for in detail for each site. This gives A&E more management, budget flexibility, and staffing control.

RESULTS ARE MEASURABLE

A&E has also seen improvement in some important industry benchmarks since working with Compliance Consultants, Inc.

A&E is proud to have an Experience Modification Rating (EMR) of .692, which is used to price workers' compensation insurance premiums and allows A&E to bid on almost all projects, whereas a higher EMR would disqualify them from bidding on many projects. Further, on average over the past five years, A&E has tracked well under the industry average* for recordable workplace injuries, while the company has grown substantially in staffing and hours worked.

A&E and CCI have formed a true partnership and with a common goal of providing the safest possible work environment for all employees, growing a culture of safety, and making sure that at the end of the day everyone gets home safety.
